## Silver Alert issued for Eaton, Indiana teenager Scottie Morris



The Eaton Police Department is investigating the disappearance of Scottie Dean Morris, a 14 year old white male, 5 foot 4 inches tall, 150 pounds, brown hair with blue eyes, last seen wearing black shoes, red and black shorts and a white T-shirt with writing on the front.

Scottie is missing from Eaton, Indiana which is 76 miles northeast of Indianapolis and was last seen on March 16, 2023 at 8:30 pm. He is believed to be in extreme danger and may require medical assistance.

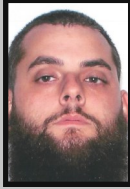
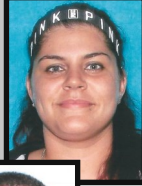
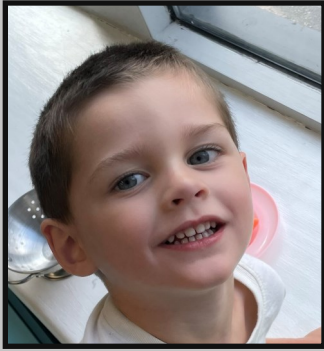

## Indiana's 2022 Active Silver Alerts

March 2023



**STEVEN BRYAN** is a 3-year-old white male, 3 feet 5 inches tall, 32 pounds, with brown hair and blue eyes. He is believed to be with **CALEB BLEVINS**, a 30-year-old white male, 6 feet tall, 225 pounds with brown hair and brown eyes.

The pair is missing from Mooresville, Indiana which is 18 miles southwest of Indianapolis and were last seen on July 20, 2022.

They may be in the company of Deborah Bryan, a 29-year-old white female, 5 feet 8 inches tall, 135 pounds with brown hair and hazel eyes, driving a Silver 2020 Toyota Rav4 with Indiana plate VSH490.

Project Lifesaver is the premier search and rescue program operated internationally by public safety agencies and is strategically designed for "at risk" individuals who are prone to the life-threatening behavior of wandering. The primary mission of Project Lifesaver is to provide timely response to save lives and reduce potential injury for adults and children with the propensity to wander due to a cognitive condition.

# NCMEC is Taking It Down:

## Helping young victims of online exploitation move forward

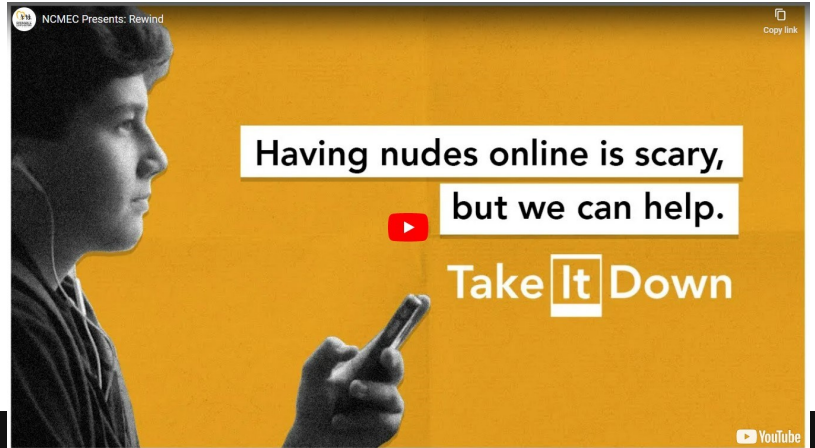
Some of our biggest opportunities for growth are found in the less-than-stellar decisions we make. Learning from our mistakes and moving forward is essential to leading a full and productive life. But what happens when those mistakes have consequences that seem insurmountable, leading only to isolation and despair?

Today's youth are faced with the same growing pains as the generations before them. But, in a digital world, missteps can escalate quickly, and for those who fall victim to online enticement, the price can be detrimental.

The National Center for Missing & Exploited Children continues to fight for today's kids, offering resources and programs to help navigate the challenges and fears.

NCMEC recently launched a new tool for survivors of online child sexual abuse. Take It Down is a platform that will help remove nude, partially nude or sexually explicit photos and videos of minors. Since the initial launch in December 2022, more than 200 cases have been submitted.

### Get Involved: CyberTipline

The National Center for Missing and Exploited Children (NCMEC) [CyberTipline](https://www.cybertipline.org) is the nation's centralized reporting system for the online exploitation of children. The public and electronic service providers can make reports of suspected online enticement of children for sexual acts, extra-familial child sexual molestation, child pornography, child sex tourism, child sex trafficking, unsolicited obscene materials sent to a child, misleading domain names, and misleading words or digital images on the internet.

NCMEC staff review each tip and work to find a potential location for the incident reported so that it may be made available to the appropriate law-enforcement agency for possible investigation. We also use the information from our CyberTipline reports to help shape our prevention and safety messages.



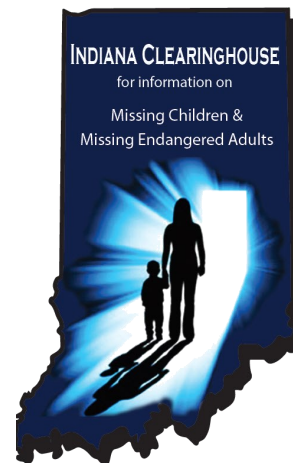

The Missing Person Bulletin is a valuable resource available for you to check and confirm if a person is identified as missing in the State of Indiana. The bulletin is updated daily Monday through Friday with information from the National Crime Information Center (NCIC) and the Indiana Data and Communication System (IDACS). Always check the date at the bottom of the page to confirm when the bulletin was last updated. If there is any doubt, feel free to call the Clearinghouse at 800-831-8953.

### National Center for Missing and Exploited Children (NCMEC)

The mission of the National Center for Missing and Exploited Children is to help find missing children, reduce child sexual exploitation, and prevent child victimization. They operate a 24/7 national hotline (1-800-THE-LOST) for tips and reports related to missing and sexually exploited children, create and distribute missing child posters, redistribute AMBER Alerts, operate the CyberTipline for child sexual exploitation, help locate victims of child sex trafficking, assist law enforcement with tracking non-compliant sex offenders, provide crisis intervention and counseling referrals, and ensure that victims of child sex trafficking have access to the recovery services and support they need.

The Indiana General Assembly established the Indiana Clearinghouse for Information on Missing Children and Missing Endangered Adults in 2009. The Clearinghouse is intended to serve as the state central repository for all information on missing children and missing endangered adults from Indiana or believed to be in Indiana. The program is designed to collect, store, and disseminate information on missing children and missing and endangered adults. The Clearinghouse provides liaison among citizens, private organizations, and law enforcement agencies regarding missing children information.
